Sweepstakes Period: Entries will be accepted online and through the mail starting June 1, 2026 at 12:01 AM EDT and ending August 31, 2026. All entries must be received by August 31, 2026 at 11:59PM EDT.

The place of arbitration shall be Summit County, Ohio.
